HEC WOULD LIKE TO INFORM THE GENERAL PUBLIC, ONGOING STUDENTS, AND GRADUATES OF THE IST-BURKINA FASO, THE FOLLOWING RESOLUTIONS OF THE MEETING:

- 1. THE IST-BURKINA FASO TO PROVIDE DETAILED CLARIFICATIONS (INCLUDING QUALITY ASSURANCE MECHANISMS) TO HEC ON THE MODE OF DELIVERY, ESPECIALLY THE BLENDED MODE OF TEACHING AND LEARNING PROVIDED TO RWANDAN STUDENTS.
- 2. THE IST-BURKINA TO SUSPEND WITH IMMEDIATE EFFECT ALL TEACHING AND LEARNING ACTIVITIES PROVIDED TO RWANDAN STUDENTS VIA BLENDED MODE UNTIL THE CLARIFICATIONS IN (1) ABOVE ARE PROVIDED.
- 3. HEC TO SUSPEND THE PROCESSING OF EQUIVALENCES FOR GRADUATES OF THE IST-BURKINA FASO/BLENDED MODE UNTIL THE CLARIFICATIONS IN (1) ABOVE ARE PROVIDED.

HEC WILL RESUME THE PROCESSING OF EQUIVALENCES FOR GRADUATES OF THE IST-BURKINA FASO/BLENDED MODE FOLLOWING THE EFFECTIVE IMPLEMENTATION OF THE RESOLUTIONS 1 &2.
